- ❖ The India Meteorological Department (IMD) has issued a cyclone alert for Maharashtra due to Cyclone 'Shakti' forming in the Arabian Sea.
- ❖ Grandmaster P. Iniyan from Tamil Nadu won the 62nd National Chess Championship held in Guntur, Andhra Pradesh.
- ❖ Indian weightlifter Mirabai Chanu won silver in the 48kg category at the 2025 World Weightlifting Championships in Forde, Norway.
- ❖ The traditional Bhavani jamakkalam was featured at London Fashion Week, earning international recognition.

- ❖ Only 1 lakh acres have been covered under Samba cultivation in the Cauvery delta this year, compared to 3.2 lakh acres during the same period last year.
- ❖ The shortfall is mainly due to delayed sowing in the Kuruvai season caused by unseasonal rains between February and April.
- ❖ Paddy coverage during the Kuruvai season rose to over 6 lakh acres this year, exceeding the usual 4.4 lakh acres and the previous year's 3.9 lakh acres.



- ❖ The harvest delay in Kuruvai is affecting the timely sowing of Samba, with around 25% of fields in Mayiladuthurai district still unharvested by the end of September.
- ❖ The Cauvery delta accounted for 26.9 lakh tonnes or 38% of Tamil Nadu's 70.5 lakh tonnes paddy output in 2023–24.

NATIONAL NEWS

MSP for Rabi Crops

- ❖ The Cabinet Committee on Economic Affairs (CCEA) approved the hike in Minimum Support Prices (MSP) for all mandated Rabi crops for the 2026–27 marketing season.
- ❖ The highest MSP hike is for safflower at ₹600 per quintal.
- ❖ It is followed by lentil (masur) at ₹300, rapeseed and mustard at ₹250, gram at ₹225, barley at ₹170, and wheat at ₹160 per quintal.
- ❖ The Union Cabinet also approved the Mission for Aatmanirbharta (self-reliance) in Pulses with an outlay of ₹11,440 crore for 2025–26 to 2030–31 to raise domestic production to 350 lakh tonnes.
- ❖ The Pulses Mission will benefit two crore farmers through improved seeds, post-harvest infrastructure, and assured procurement of climate-resilient varieties.

Aspirational Agricultural Districts

- ❖ The government launched the Prime Minister Dhan-Dhaanya Krishi Yojana (PMDDKY) to develop 100 aspirational agricultural districts.
- ❖ The scheme covers 29 states and union territories, with Uttar Pradesh having the most districts at 12.

- ❖ The program aims to improve agricultural productivity, crop diversification, irrigation, and credit access.
- ❖ PMDDKY will use 36 existing schemes from 11 government departments without a separate budget.
- ❖ The districts were chosen based on low productivity, moderate crop intensity, and poor access to credit.

Govt will undertake 'Prime Minister Dhan-Dhaanya Krishi Yojana' in partnership with states to help around **1.7 crore farmers**

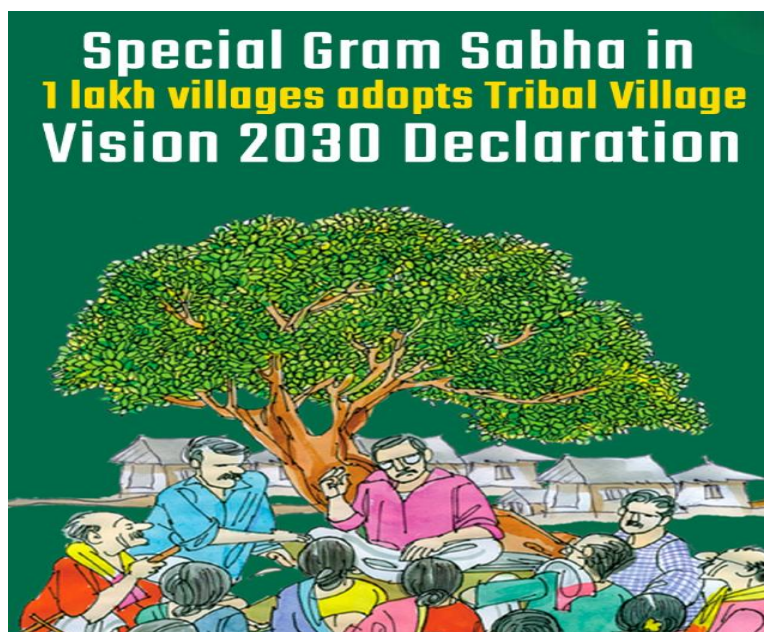
It will cover **100 districts** with low productivity, moderate crop intensity and below-average credit parameters

- Facilitate availability of long-term & short-term credit



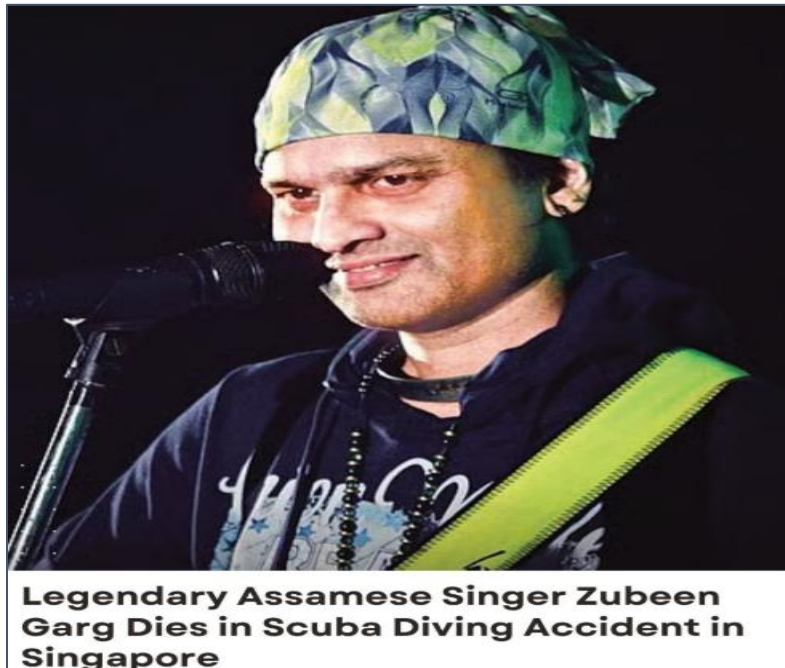
Tribal Village Vision 2030 declaration



- ❖ The Tribal Village Vision 2030 declaration was passed in special Gram Sabhas on October 2, 2025.
- ❖ The Ministry of Tribal Affairs launched the Adi Karmayogi Abhiyan, the world's largest tribal grassroots leadership mission.
- ❖ The mission reached over 11.5 crore tribal citizens across 1 lakh villages and tolas in 30 states and union territories.
- ❖ One lakh Adi Sewa Kendras, or citizen service centres, are being established with weekly voluntary service from villagers.
- ❖ The AI-powered Adi Vaani application connects government officers with tribal communities in native languages for real-time communication.
- ❖ Since July 2025, 20 lakh officials, self-help group women, and tribal youth have been trained as Adi Karmayogis to ensure last-mile delivery of government schemes.

INTERNATIONAL NEWS

MLAT – Singapore



- ❖ Zubeen Garg, a famous Indian singer and cultural icon from Assam, died in Singapore.
- ❖ The island where he was found unconscious has been renamed “Zubeen Garg Island” on Google Maps as a tribute.

- ❖ The Assam Government has formed a 10-member Special Investigation Team (SIT).
- ❖ The Centre has invoked the Mutual Legal Assistance Treaty (MLAT) with Singapore to seek cooperation in the investigation.

Poland Joins NATO Pipeline



- ❖ Poland announced a 4.7-billion- euro plan to join the NATO Pipeline System (NPS).
- ❖ The NATO Pipeline System is a 10,000-kilometre network supplying fuel and lubricants for military operations across Europe.
- ❖ During the Cold War, Poland was part of the Warsaw Pact, so NATO pipelines did not reach its bases near Russia and Belarus.
- ❖ Poland plans to build a 300-kilometre pipeline from Germany to its military base in Bydgoszcz, home to NATO's joint force training centre.
- ❖ The project will be built and operated by Poland and PERN, pending approval from all 32 NATO allies.
- ❖ Poland is NATO's top military spender relative to GDP and a key ally of Ukraine amid ongoing tensions with Russia.

Net-Zero Banking Alliance

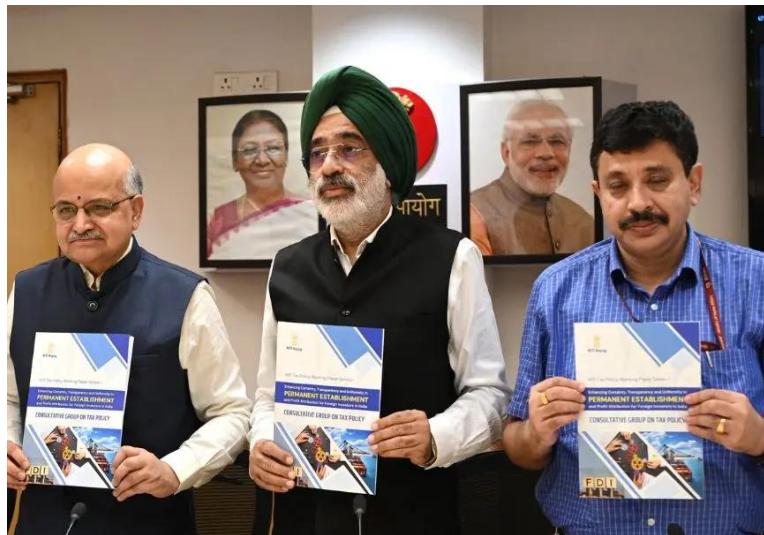
- ❖ The Net-Zero Banking Alliance (NZBA), launched in 2021 to drive banking sector decarbonisation, is ending operations.

- ❖ The closure follows a mass exit of banks amid U.S. political pressure and antitrust concerns.
- ❖ NZBA's climate target-setting guidance will remain available for banks to use.
- ❖ This shutdown is similar to recent closures of climate initiatives in the insurance and asset management industries.



ECONOMY NEWS

Working Paper on Enhancing Tax Certainty



- ❖ NITI Aayog introduced its first Tax Policy Working Paper titled “Enhancing Tax Certainty in Permanent Establishment and Profit Attribution for Foreign Investors in India”.
- ❖ It aims to boost transparency and predictability in tax regulations.
- ❖ The paper addresses long-standing issues faced by foreign investors related to Permanent Establishment (PE) rules, profit attribution, and dispute resolution to improve India's investment climate.

- ❖ It proposes an optional, industry-specific Presumptive Taxation Scheme for foreign companies to reduce litigation, simplify compliance, and enhance administrative efficiency.

Global Use of Rupee



- ❖ The Reserve Bank of India (RBI) allowed Indian banks to lend in rupees to non-residents from Bhutan, Nepal, and Sri Lanka for cross-border trade.
- ❖ RBI proposed transparent reference rates for major foreign currencies to promote rupee-based transactions.
- ❖ RBI permitted Special Rupee Vostro Account (SRVA) balances to be invested in corporate bonds and commercial papers.
- ❖ India's current account deficit was \$2.4 billion or 0.2% of GDP in Q1 2025–26, down from \$8.6 billion or 0.9% in Q1 2024–25.
- ❖ As of September 26, 2025, India's foreign exchange reserves stood at \$700.2 billion, covering over 11 months of imports.

SRO Status to FIDC

- ❖ The Reserve Bank of India (RBI) granted self-regulatory organisation (SRO) status to the Finance Industry Development Council (FIDC) on October 3, 2025.
- ❖ The FIDC represents non-banking financial companies (NBFCs) registered with the RBI across India.
- ❖ SROs help develop industry standards, monitor compliance, and support early detection of risks in the financial system.

- ❖ This move follows the RBI's 2023 framework for recognising SROs in financial markets.
- ❖ FIDC will now work with RBI to ensure regulatory compliance and enhance transparency in the non-bank lending sector.

**RBI GRANTS FINAL SRO RECOGNITION TO FINANCE
INDUSTRY DEVELOPMENT COUNCIL (FIDC)**

Mumbai, October 3, 2025

Finance Industry Development Council (FIDC), the representative body of Non-Banking Financial Companies (NBFCs), has been granted **final recognition by the Reserve Bank of India as the Self-Regulatory Organisation (SRO) for the NBFC sector.**

This recognition is a **landmark moment** for the NBFC sector, underscoring its critical role in India's financial system and its growing contribution to financial inclusion.

SCIENCE AND TECHNOLOGY NEWS

SARAL tool



- ❖ The Anusandhan National Research Foundation (ANRF), India's newest science funding agency, has developed a tool called SARAL.
- ❖ SARAL stands for Simplified and Automated Research Amplification and Learning
- ❖ It uses artificial intelligence (AI) to generate layperson summaries of complex scientific research papers.

- ❖ The tool can create videos, podcasts, posters, and presentations to make research more accessible.
- ❖ ANRF aims to support deep science and engineering to foster deep tech products and startups in areas like drug discovery, aerospace, climate, and advanced materials.

Complex Organics in Enceladus

- ❖ The Cassini spacecraft found new complex organic molecules in fresh ice grains ejected from Saturn's moon Enceladus.
- ❖ It also, detected compounds include aliphatic, cyclic esters, ethers, and possible nitrogen- and oxygen-bearing molecules.
- ❖ These molecules originate from Enceladus's subsurface ocean, not from long-term radiation exposure in Saturn's E ring.
- ❖ The findings confirm active complex chemistry in Enceladus's ocean, strengthening the case for a future ESA (European Space Agency) mission to the moon.



ENVIRONMENT NEWS

Snow Leopard Population in Himachal Pradesh

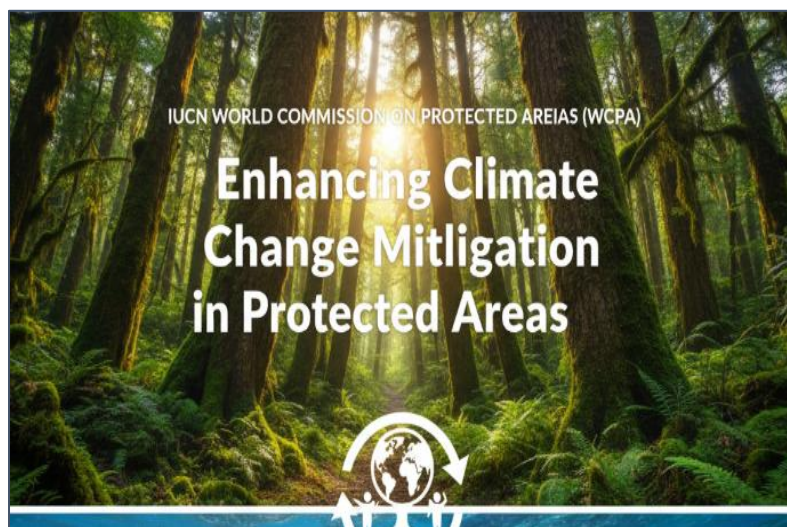
- ❖ The snow leopard population in Himachal Pradesh has risen by 62 percent in four years, reaching 83 in 2025.
- ❖ The Forest Department's Wildlife Wing surveyed between 2021 and 2025.

- ❖ The population increased from 51 in 2021 to 83 in 2025, exceeding earlier estimates.
- ❖ Snow leopards were observed in the tribal districts of Lahaul-Spiti, Kinnaur, and Pangri Valley.



REPORTS AND INDICES

IUCN WCPA Report 2025



- ❖ The IUCN World Commission on Protected Areas (WCPA) released the report named “Enhancing Climate Change Mitigation in Protected Areas.”
- ❖ Protected and Conserved Areas (PCAs) safeguard biodiversity, cultural resources, and support sustainable development.

- ❖ PCAs help remove carbon dioxide, prevent carbon release, and may enable large-scale carbon removal depending on their type.
- ❖ Protecting 30% of land could lock in 500 billion tonnes of carbon, and protecting 30% of oceans could reduce 20% of emissions needed for the Paris Agreement.

PERSONALITIES, AWARDS, AND EVENTS

Inspire Award MANAK Scheme

- ❖ Uttar Pradesh recorded 2,80,747 nominations under the Inspire Award MANAK scheme in 2025, the highest since the scheme began.
- ❖ The scheme, run by the Department of Science and Technology, Government of India, encourages innovation among students of classes 6 to 12.
- ❖ Among the top 50 districts in India by nomination count, 22 are from Uttar Pradesh, including Pratapgarh (7,085) and Prayagraj (6,929).
- ❖ UP surpassed Rajasthan (1,41,142 nominations) and Karnataka (1,01,656), with a margin of 1.39 lakh and 1.79 lakh nominations, respectively.



MISCELLANEOUS NEWS

Mud Volcano in Andaman

- ❖ India's only mud volcano at Baratang in the Andaman and Nicobar Islands erupted on October 2, 2025.



- ❖ The volcano had remained dormant since its last major eruption in 2005.
- ❖ Mud volcanoes are formed by gases like methane pushing mud to the surface, unlike lava-based volcanoes.
- ❖ This event is separate from recent minor eruptions at Barren Island, which is India's only active lava volcano.
