TNPSC BITS

- The Union minister for Statistics and Programme Implementation D V Sadananda Gowda has assumed the additional charge of the Ministry of Chemicals and Fertilisers.
 - The move was necessitated following the demise of Ananth Kumar who held that portfolio.
- ❖ Justice Vineet Kothari was sworn in as a judge of the Madras High Court. With this, the number of judges in the Madras High Court has gone up to 61 as against the sanctioned strength of 75.
- ❖ The scholar-epigraphist Padma Shri Iravatham Mahadevan passed away at the age of 88 on November 26 in Chennai.

TAMIL NADU

Gaja cyclone - Central Committee

- ❖ The inter-ministerial team headed by Daniel E Richard has recently assessed the havoc wreaked by cyclone Gaja.
- ❖ The Central team consisting of seven members completed its three-day assessment in Tamil Nadu and Puducherry.
- ❖ Daniel Richard is currently the joint secretary of the Union Home Ministry.
- ❖ The report will be submitted for the consideration by the appropriate committees in the government.

NATIONAL

Cabinet Approvals

- ❖ The Union Cabinet has approved a Memorandum of Understanding (MoU) between India and Tajikistan on Cooperation on Youth Matters valid for a period of 5 years.
- ❖ The Union Cabinet has approved Agreement on Cooperation (AoC) in the field of Science, Technology and Innovation between India and Uzbekistan.





- ❖ The Union Cabinet has approved Memorandum of Understanding (MoU) between Atal Innovation Mission of India and Fund "Talent and Success" of Russia for promotion of science & technology.
- ❖ The Union Cabinet has approved a MoU between India and Mauritius on Consumer Protection and Legal Metrology.

Ban on CBI

- ❖ Andhra Pradesh and West Bengal state governments withdrew the 'General Consent' accorded to the CBI (Central Bureau of Investigation) to conduct its operations in their states.
- Unlike the National Investigation Agency (NIA), which is governed by its own NIA Act, 2008 and has jurisdiction across the country.
 - o The CBI is governed by the Delhi Special Police Establishment Act, 1946.
- ❖ This makes consent of a state government mandatory for conducting investigation in that state.

INTERNATIONAL

Annual Ease of Doing Business in India Report

- ❖ The UK India Business Council (UKIBC) has recently released its '4th Annual Ease of Doing Business in India Report: The UK Perspective'.
- ❖ It highlights that UK businesses' perceptions of corruption as a barrier to operating in India has halved since 2015.
- ❖ 25% of UK businesses saw corruption as a major barrier in 2018, as opposed to 51% in 2015.
- ❖ 46% of UK Businesses responding had plans to expand their investments in India in the next 12 months.
- ❖ Moreover 25% of those responding intend to direct this new investment eastwards
 - o seeking new opportunities in states such as West Bengal, Assam, Meghalaya and Manipur.





ECONOMY

Panel to examine Economic Capital Framework

- ❖ The RBI, in its board meeting, has decided to set up an expert committee to examine the central bank's Economic Capital Framework (ECF).
- ❖ It will decide the amount of reserves RBI can maintain and handing over the balance to the government.
- The panel has been setup to examine the framework to enable transfer of reserve worth Rs 3.6 lakh crore to Government of India.
- The membership and terms of reference of the committee will be jointly determined by the government and the RBI.



- ❖ This decision was made after a key demand of the government on the same for transfer of a surplus of Rs 3.6 lakh crore.
- ❖ This is more than a third of the total Rs 9.6 lakh crore reserves of the central bank to the government.
- ❖ The RBI agreed to consider a scheme for restructuring of stressed standard assets of MSME (Micro, Small and Medium Enterprises) borrowers with aggregate credit facilities of up to Rs 250 million.

Background

❖ The decision comes in the wake of difference of opinion between the RBI governor and the Finance Ministry over certain issues, which has resulted in a public spat.

STATES

J&K Governor dissolves assembly

- ❖ The Jammu & Kashmir governor Satya Pal Malik unexpectedly dissolved the state legislative assembly late on November 21, 2018.
- ❖ The move came hours after the People's Democratic Party (PDP) leader Mehbooba Mufti staked claim to form a government with the backing of the National Conference (NC) and the Congress.
- The governor cited,
 - o "extensive horse-trading" and
 - o The "impossibility" of forming a stable government by coming together of political parties with "opposing political ideologies".

PERSONALITIES, AWARDS AND EVENTS

CII-Exim Bank Business Award

❖ The Bharat Electronics Limited (BEL) won the CII-Exim Bank Business Excellence Award, for being a role-model organization, at the Quality Summit in Bengaluru.





- ❖ The Summit was organized by the Confederation of Indian Industry (CII).
- ❖ The BEL company's Bengaluru complex is the first state-run undertaking to be recognized as a role-model organization by the CII.
- ❖ 3 other BEL units at Ghaziabad (UP), Chennai (TN) and Machilipatnam (AP) received the Platinum recognition for business excellence.

CII-Exim Bank Business Award

- ❖ The award is the highest recognition in the CII-Exim Bank Award for Business Excellence.
- ❖ The award is instituted by the CII and the Export-Import Bank of India to enhance the competitiveness of India Inc.
- ❖ The CII recognizes organizations at three levels Gold Plus, Platinum and Award at the highest.

Chairman of Union Public Service Commission

- ❖ The President has appointed Arvind Saxena as the Chairman of Union Public Service Commission (UPSC).
- ❖ He will have tenure till August 7, 2020, when he attains the age of 65 years.
- ❖ The UPSC is a constitutional body which conducts the prestigious civil services examination to select IAS, IFS and IPS officers among others.
- ❖ It has been established under Article 315 of the Constitution and consists of a Chairman and ten Members appointed and removed by the President.
- ❖ The chairman and members of the Commission hold office for a term if six years or until they attain the age of 65 years, whichever is earlier.

SPORTS

Abu Dhabi Grand Prix

- ❖ The Five-time World champion Lewis Hamilton won the Etihad Airways Abu Dhabi Grand Prix for a record fourth time.
- ❖ He signed off the season by winning at the Abu Dhabi Grand Prix, the 21st and final race of the 2018 F1 calendar at the Yas Marina Circuit, Abu Dhabi.
- ❖ The title is his 11th win of this year's campaign and overall 73rd career win and is now 18 wins away from Michael Schumacher's all-time record.





- ❖ Sebastian Vettel of Ferrari and Max Verstappen of Red Bull Racing TAG Heuer were at 2nd and 3rd position in the race.
- ❖ The Briton became the first driver to score more than 400 points in a season with a final tally of 408.

IMPORTANT DAYS

Africa Industrialization Day (AID) - 20 November

- ❖ The Africa Industrialization Day was celebrated on 20th November every year by UN General Assembly.
- ❖ The Theme for the 2018 edition is: "Promoting Regional Value Chains in Africa: A pathway for accelerating Africa's structural transformation, industrialization and pharmaceutical production".
- ❖ It focused on the context of the Africa Continental Free Trade Agreement (AfCFTA) and the Third Industrial Development Decade for Africa (IDDA III).
- ❖ It was first established in 1989 by UNGA to raise awareness about the importance of Africa's industrialization and the challenges faced by the continent.

70th NCC Raising Day

❖ World's largest Uniformed Youth Organization, National Cadet Corps (NCC) celebrated 70th NCC Raising day all over India on 25th November 2018.

India Rivers Week 2018

- ❖ The India Rivers Week (IRW) 2018, a unique meeting on rivers in India was held at the World-Wide Fund for Nature-India (WWF), New Delhi from November 24 to 26, 2018.
- The focus of this year's three-day meet was 'Can India Rejuvenate Ganga?'
- ❖ This year's event was dedicated to Dr G D Agrawal also known as Swami Gyanswarup Sanand, who passed away recently.





Indian Organ Donation Day - 27 November

- ❖ National Organ and Tissue Transplant Organization (NOTTO), on 27th November 2018organized 9th Indian Organ Donation Day in Delhi.
- ❖ Various Awards in the area of Organ Donation and Transplant were distributed in the event.

Guinness World Record on Rubik's Cubes

China's 13-year-old Que Jianyu has created a Guinness World Record by solving 3 Rubik's Cubes simultaneously in just 1 minute 36.39 seconds, using his hands and feet.



- ❖ He also set a Guinness World Record for the fastest time to solve a Rubik's cube upside down (15.84 seconds) beating the previous best by 1.6 seconds.
- ❖ He already holds the fastest time to solve three Rubik's cubes while juggling (5 minutes 6.61 seconds).
